

The Applicant shall pay to the Bank such charges and fees pertaining to the granting and management of the Guarantee as included in the Bank's tariff in force at the time of signing of this Application. The Bank is entitled to amend such charges and fees. The Bank may increase the charges and fees charged for the bank guarantee valid in the Bank's tariff at the time the application is signed.

The amendments in the charges and fees are published by the Bank in the Bank's tariff. Such amendment will enter into force at a time stated by the Bank, however, at the earliest at the beginning of the calendar month commencing one month after the date on which the amendment was published in the Bank's tariff. The Bank's tariff is available at all branches of the Bank in Finland.

This Appendix contains the grounds for such charges and fees payable on the Guarantee together with the amounts in force at the time of signing, which the Applicant is liable to pay to the Bank when the Applicant applies for the Guarantee and the Bank manages the Guarantee in accordance with the General Terms and Conditions. It does not include such charges, fees and compensations that the Applicant is liable to pay to the Bank due to his payment default, or which arise from amendments to the Guarantee or its terms, or from other action requested from the Bank by the Applicant or caused by the Applicant's measures.

The Applicant shall pay to the Bank charges and fees incurred by the Bank due to collection of amounts paid by the Bank under the collection of commission, interest or fees based on the issuance of the Guarantee.
